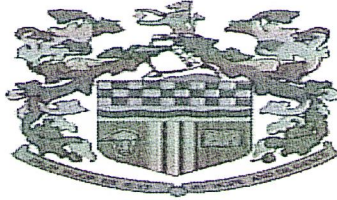

## **REQUEST FOR FORMAL WRITTEN PRICE QUOTATIONS**

### **BID NO: RFQ 07/2024/25**

Magareng Municipality hereby invites suitably service providers to bid for rental and installation of two raw water pumps from the 24<sup>th</sup> November till the 2<sup>nd</sup> December 2024

#### **Specification**

- Install raw water river pumps at Vaal River and supply raw water to the Water Treatment Plant
- Installation of electrical cable joints
- Rental of TLB
- Provide security for the duration of service

The quotes must reach the municipality by not later than **12h00; 21 November 2024.**

1. Late, emailed, faxed, incomplete quotes will not be considered.
2. All quotes will be adjudicated and awarded in terms of the Magareng Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act of 2022 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.

3. **Suppliers must submit their quotes with the following documentation and or information:**

- 3.1 A valid original Tax Clearance certificate or valid tax pin.

3.2 A certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which are overdue more than 90 days, if the bidder is the lessee a valid lease agreement together with the municipal account of the landlord or director if a company is a sole owner, or a letter from tribal authority if the service provider operates in rural areas.

3.3 Quotes must be valid for a period of 30 days

3.4 MBD 4, 6.1, 8 and 9 must be fully completed and signed together with quotation.


3.5 Bidders must be registered on the Central Supplier Data Base and must be compliant.

3.6 in terms of procurement preferential policy, the municipality aims to achieve Historical Disadvantage Individuals(HDI) special goal. Therefore, the whole 20 points PPPFA will be towards the specific goal for Enterprises with ownership of 51% or more by person/s who are black.

**5. The Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid if (a) the bid amounts received are too high; (b) the bids do not comply with the specific bid goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any bids.**
