Tender documents are set to be completed in black ink and in accordance with the conditions and rules contained in the bid document. Tender document shall be available on **E-Tender** on **Monday, 12 May 2025**. Therefore bidders have to print the tender document for themselves and complete it and thereafter submit it at the Municipality on or before the closing date and time.

The completed Tender documents must be clearly **marked "Corp05/2024/25 Supply and Installation of Council Chamber Recording System with Maintenance for a period of 3 years"** and placed in the Tender Box, situated at the main reception area of Magareng Local Municipality, Magrieta Prinsloo Street, Warrenton, 8530, no later than **the closing date, 23 May 2025**.

Tenderers are required to submit a municipal account bearing the Tenderers Entity's name as proof of payment of municipal services which is not older than 3 months and must not be in arrears for more than 3 months at the tender closing date.

If the value of the tender amount is expected to exceed R 10 million (VAT included) and if the bidder is required by law to prepare annual financial statements for auditing purposes. The bidder must submit, their audited annual financial statements-

- for the past three years; or
- since their establishment if established during the past three years.

Telephonic, facsimile, email and/or late bids will not be accepted. Bids must be valid for a period of ninety (90) days after the closing date of the bid.

The tenders will be evaluated in terms of the 80/20 preference points system of which 80 points will be for price and 20 points for specific goals for the various bids are indicated below: **CORP05/2024/25:**
