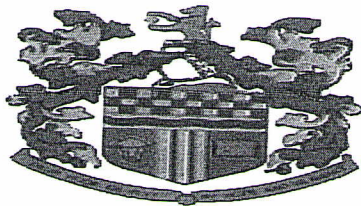

Magareng Municipality hereby invites suitably service providers with 2EP; 2ME or 2 CE CIDB grading to bid for:

REFURBISHMENT OF WARRENTON WASTE WATER TREATMENT PLANT AND N12 PUMP STATION

The compulsory site briefing will be held at Magareng Council Chamber on 25 November 2020 at 10:00.

The bids must reach the municipality by not later than **12h00; 03 December 2020**

1. All bids will be adjudicated and awarded in terms of the Magareng Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of Contract and, if applicable, any other Special Condition of Contract.

Late, incomplete quotes will not be considered.

3. Suppliers must submit their bids with the following documentation and or information:

- 3.1. A valid original Tax Clearance certificate or SARS pin.
- 3.2. Proof of fully paid municipal account not older than 90 days or if the bidder lives in the rural area, he or she should get proof of residence from the chief of the village of the area
- 3.3. CIPC certificates.
- 3.4. Certified evidence of B-B.B.E.E. contributor status by SANAS, IRBA or SANAS accredited agencies; or a sworn DTI affidavit.

- 3.5. Completed and signed MBD forms attached on the bidding document.
- 3.6. Bidders must furnish their CSD numbers on the quotes (MAAA number).
4. Bids to hold goods for 90 days.
5. Bids must be sealed and envelope must be clearly marked "Refurbishment of warrenton waste water treatment plant and N12 pump station: Tech: 02/2020/21".
6. Both the lease agreement and municipal account's addresses must match CSD address


Bids must only be submitted on the bid documentation provided by the municipality.
