
Bid requirements and or disqualification criteria:

1. Late, emailed, faxed, incomplete proposals will not be considered. All quotes will be adjudicated and awarded in terms of the Magareng Local Municipality Procurement and Supply Chain Management Policy, the Preferential Procurement Policy Framework Act , Act No.5 of 2000 and the regulations promulgated under this Act. This bid is subject to the General Conditions of the Contract and, if applicable, any other Special Condition of Contract.

2. **Suppliers must submit their quotes with the following documentation and or information:**
- 2.1 A Valid original Tax Clearance certificate;
 - 2.2 A certificate certifying that the bidder has no undisputed commitments for **Municipal services** towards a municipality or service provider i.r.o. payments which are overdue more than 30 days; if the bidder is the lessee a valid lease agreement together with the **Municipal account** of the landlord or a director.
 - 2.3 Certified evidence of **B-B.B.E.E.** contributor status by **SANAS, IRBA** or **SANAS** accredited agencies or **valid affidavit**.
 3. **MBD 4, 8 and 9** must be fully completed, obtainable from SCM office during Working hours or download from MLM website www.maqareng.co.za
 4. Bidders must be registered on the **Central Supplier Data Base (CSD)**, proof of registration to be submitted and or the registration number to be indicated on proposals for verification of registration.
